**THE EAST AFRICAN COMMUNITY  
APPROPRIATION ACT, 2016**

**An Act of the Community to make appropriation out of the East African Community Budget to the service of the financial year ending 30th June, 2017.**

*Date of assent:* 16th November, 2019.

*Date of commencement:* 1st July, 2016.

ENACTED by the East African Community and assented to by the Heads of State.

**1.** This Act may be cited as the East African Community Appropriation Act, 2016 and shall come into force on the 1st day of July, 2016. Citation and commencement

**2.** The Secretary General may issue out of the budget of the East African Community and apply towards the supply granted to the Community for the services of the year ending 30th June, 2017 the sum of United States Dollars One Hundred One Million, Three Hundred Seventy Four Thousand, Five Hundred Eighty Nine. Issue of money out of the Community budget

Appropriation of sums granted

**3.** The sums granted by this Act shall be appropriated for the services and purposes specified in the Schedule to this Act.

Payment for services in previous financial year.

**4.** Any part of the sums granted by section 2 which has been, or is issued from the budget of the East African Community before the 30th June, 2017 shall be available until a date to be determined by the Council of Ministers, not being later than the 31st day of December, 2017 for making payments which become due during the year ending on the 30th June, 2017.
