REPORT OF THE THIRD MEETING OF TRIPARTITE COUNCIL OF MINISTERS

8 June 2015 Sharm El Sheikh, Egypt

Introduction

- 1. The Third Meeting of the Tripartite Council of Ministers was held on 8 June 2015 in Sharm El Sheikh, Egypt. The main objective of the meeting was to prepare for the Third Tripartite Summit of Heads of State and Government to be held on 10 June 2015.
- 2. The meeting was attended by Ministers and officials from Angola, Botswana, Burundi, Comoros, Djibouti, DR Congo, Egypt, Eritrea, Ethiopia, Kenya, Lesotho, Madagascar, Malawi, Mauritius, Mozambique, Namibia, Rwanda, Seychelles, South Africa, Sudan, Swaziland, Tanzania, Uganda, Zambia and Zimbabwe. The meeting was also attended by officials from the Tripartite Task Force (TTF) comprising of the Secretariats of COMESA, EAC and SADC. The list of participants is attached as **Appendix 1**.

Welcome and Opening Remarks (Agenda Item 1)

Statement of the Chairperson

- 3. The Chairperson of the Council of Ministers Hon Mike Bimha, Minister of Industry and Commerce of Zimbabwe, welcomed delegates to the Third Tripartite Council of Ministers meeting and expressed profound gratitude to the Government of Egypt for the warm hospitality, including the excellent facilities. He further appreciated the work of the Tripartite Task Force in organising the meetings that would culminate into the launch of the TFTA.
- 4. The Chairperson then invited the Guest of Honour to officially open the meeting.

Statement by the Representative of the Host Country

5. The Third Tripartite Council of Ministers was officially opened by Honourable Mounir Fakhry Abdelnour, Minister of Industry, Trade and SMEs of Egypt. On behalf of the Egyptian Government, he welcomed Ministers and their delegations to Sharm El Sheikh, Egypt. He reiterated Egypt's commitment to the integration process of the African continent. He highlighted the history of Africa's integration efforts which dates back to 1910 when the Southern African Customs Union (SACU) was formed. He noted that the launch of the TFTA marks a new era in the trading relations in the three RECs. He further noted that the TFTA will promote industrialization, enhance productive capacity as well as address the issue of infrastructure deficit in the Tripartite region.
