PART I RECOMMENDATIONS ON THE APPOINTMENT OF ONE NEW DEPUTY SECRETARY GENERAL FROM THE REPUBLIC OF KENYA

1.1 END OF TENURE OF DR. JULIUS TANGUS ROTICH

The Council was informed that the contract of service of Dr. Julius T. Rotich, who was appointed Deputy Secretary General by the Summit of Heads of State ("the Summit") on 18* June 2007 and whose contract was renewed on 28th June 2010, will expire on 28th June 2013. By the provisions of the Treaty this contract cannot be renewed and the Summit has to appoint another Kenyan national as Deputy Secretary General in replacement of Dr. Julius T. Rotich.

1.2 PROPOSED NEW DEPUTY SECRETARY GENERAL

The Council was informed that by her letter Ref EAC/5/13 Vol.11 (16) dated 1st March 2013 addressed to the Secretary General, the Republic of Kenya had recommended Mr. Charles Jackson Kinyanjui Njoroge EBS for consideration by The Council of Ministers and subsequent appointment by the Summit as Deputy Secretary General.

The Council -

- (a) commended Dr. Julius Tangus Rotich for his exemplary service to the Community (EAC/CM/EX/26/Decision 01); and
- (b) recommended to the Summit to appoint Mr. Charles Jackson Kinyanjui Njoroge, EBS as a Deputy Secretary General in charge of Political Federation (EAC/CM/EX/26/Recommendation 01).

PART II PROPOSAL TO ESTABLISH THE BUREAU OF SPEAKERS AS AN ORGAN OF THE EAST AFRICAN COMMUNITY

The Council was informed that the Rt. Hon. Speakers of the EAC National Assemblies/Parliaments established a Forum of EAC Speakers in 2008. Accordingly, in her letter ref. EALA/CORD/9(3) dated 8th October, 2012 to the Chairperson of the Council, requested the Summit to consider transforming the Bureau of Speakers into an Organ of the Community.

The Council recommended to the Summit of Heads of State that it is not appropriate to establish the Bureau of Speakers as an Organ of the East African Community (EAC/CM/EX/26/Recommendation 02).

PART III PROGRESS REPORT ON THE IMPLEMENTATION OF THE DIRECTIVE OF THE SUMMIT ON EXTENSION OF THE JURISDICTION OF THE EAST AFRICAN COURT OF JUSTICE

The Council -

- (a) took note of the progress made (EAC/CM/EX/26/Decision 02):
- (b) directed Partner States to submit comments on the technical paper on the Implementation of the Summit Directive on extension of the Jurisdiction of the East African Court of Justice by 30th May, 2013 for consideration by the 15th Meeting of the Sectoral Council on Legal and Judicial Affairs (EACICM/EX/26/Directive 01); and
- (c) directed the Secretary General to ensure that Agenda items for the Extra-Ordinary Summit should contain only those items decided by the Heads of State and that additional matters should be endorsed by the Chairperson of the Council in consultation with the other members of the Council (EAC/CM/EX/26/Directive 02).

PART IV:PROGRESS REPORT ON THE NEGOTIATIONS OF THE PROTOCOL ON THE ESTABLISHMENT OF THE EAST AFRICAN COMMUNITY MONETARY UNION

The Council-

(a) took note of the progress made on the negotiations of the Protocol on the Establishment of the EAC Monetary. Union and the schedule of meetings (EAC/CM:EX. 26: Decision 03); and

- (b) directed Partner States to ensure that negotiations for the draft Protocol on the Establishment of the EAC Monetary Union are concluded by August 2013 (EAC/CM/EX/26/Directive 03);
- directed the Secretariat to consult with Partner States on new suitable dates of meetings of the Sectoral Council on Finance and Economic affairs and Pre-Budget; and Sectoral on Monetary Union and convene them expeditiously (EAC/CM/EX/26/Directive 04).

PART V DRAFT PROTOCOL ON IMMUNITIES AND PRIVILEGES OF THE EAST AFRICAN COMMUNITY, ITS ORGANS AND INSTITUTIONS

The Council -

- (a) took note of the above developments (EAC/CM/EX/26/Decision 04); and
- (b) decided to refer the Draft Protocol on Immunities and Privileges to the Sectoral Council on Legal and Judicial Affairs for legal input on Articles 2, 3 and 11 (EAC/CM/EX/26/Decision 05).

- (v) direct the Secretariat to prepare a comprehensive technical paper which will enable the Community to operationalise (i)-(iv) above to be submitted to the 27th Meeting of the Council for approval (EAC/CM/EX/26/Directive 07).

1.0 APPOINTMENT OF NEW DEPUTY SECRETARY GENERAL FROM THE REPUBLIC OF KENYA

The Summit was informed by the Council that the contract of service of Dr. Julius T. Rotich, who was appointed Deputy Secretary General by the Summit on 18th June 2007 and which contract was renewed on 28th June 2010, will expire on 28th June 2013. Pursuant to the provisions of Article 68 of the Treaty for the Establishment of the East African Community ("the Treaty") this contract cannot be renewed and the Summit had to appoint another Kenyan national as Deputy Secretary General in replacement of Dr Rotich.

At its 26th Extraordinary Meeting held on 26th April 2013, the Council recommended to the Summit to appoint Mr. Charles Jackson Kinyanjui Njoroge, MBS as Deputy Secretary General with effect from 29th June 2013 and in accordance with Article 68 of the Treaty.

The Summit -

- (a) considered the Council's recommendation and, pursuant to Article 68 of the Treaty, appointed Mr. Charles Jackson Kinyanjui Njoroge, MBS as Deputy Secretary General with effect from 29th June 2013; and
- (b) thanked Dr. Rotich for his dedicated service to the East African Community. (EAC/SHS EX 11/Decision 01)

2.0 APPOINTMENT OF TWO NEW JUDGES FROM THE REPUBLIC OF BURUNDI AND THE REPUBLIC OF RWANDA

3.1 Appointment of the Judges

The Summit received a report from the Secretary General that the tenure of service of the following persons who were appointed Judges of the East African Court of Justice on 26th June 2008 will, by effluxion of time, expire on 26th June 2013:-

- (a) Hon, Mr. Justice Laurent Nzosaba, Appellate Division; and
- (b) Hon, Mr. Justice Johnston Busingye, Court of First Instance and Principal Judge.

These Judges are nationals of the Republic of Burundi and the Republic of Rwanda respectively.

The Republic of Barundi and the Republic of Rwanda have respectively nominated His Lordship Mr. Justice Liboire Nkurunziza and His Lordship Mr. Justice Dr. Faustin Ntezilyayo as persons of proven integrity, impartiality and independence and who fulfil the conditions required in each of the Republic of Burundi and the Republic of Rwanda for the holding of high judicial office for appointment as new Judges of the East African Court of Justice.

The Summit considered this report and the nominations and, pursuant to the provisions of Article 24(1) of the Treaty appointed—

- (a) Hon, Mr. Justice Liboire Nkurunziza Judge of the East African Court of Justice in the Appellate Division; and
- (b) Mr. Justice Dr. Faustin Ntezilyayo Judge of the East African Court of Justice in the First Instance Division. (EAC/SHS EX 11/Decision 02) with effect from 27th June 2013.

3.2 Designation of a New Principal Judge

The Secretary General informed the Summit that it ("the Summit") was expected to designate a Principal Judge of the East African Court of Justice in replacement of Hon, Mr. Justice Johnston Busingve whose contract expires on 26th June 2013.

The Summit, pursuant to Article 24(5) of the Treaty and taking into account considerations of seniority in service and durations of contracts of the Judges in the First Instance Division, designated Hon. Mr. Justice Jean Bosco Butasi as Principal Judge of the East African Court of Justice with effect from 27th June 2013. (EAC/SHS EX 11/Decision 03)

4. CONSIDERATION OF THE PROGRESS REPORT OF THE COUNCIL OF MINISTERS ON THE IMPLEMENTATION OF THE DIRECTIVE OF THE SUMMIT ON EXTENSION OF JURISDICTION OF THE EAST AFRICAN COURT OF JUSTICE

The Summit directed the Council to expedite finalization of the extension of jurisdiction of the East African Court of Justice and report progress at the 15th Ordinary Summit scheduled for November 2013. (EAC/SHS EX 11/Directive 01)

4.0 CONSIDERATION OF A PROGRESS REPORT OF THE COUNCIL OF MINISTERS ON THE NEGOTIATIONS OF THE PROTOCOL ON THE ESTABLISHMENT OF THE EAST AFRICAN MONETARY UNION

The Summit-

- (a) took note of the progress made on the negotiations of the draft Protocol on the Establishment of the EAC Monetary Union; and (EAC/SHS EX 11/Decision 04)
- (b) directed the Council to ensure that negotiations of the draft Protocol are concluded by August 2013 with a view to signing the Protocol at the 15th Summit scheduled for November 2013.
 (EAC/SHS EX 11/Directive 02)

5.0 CONSIDERATION OF A PROPOSAL BY THE BUREAU OF SPEAKERS TO UPGRADE THE BUREAU INTO AN ORGAN OF THE COMMUNITY

The Summit considered the recommendations of the Council on the proposal to establish the Bureau of Speakers as an Organ of the Community; and

- (a) decided that it was not appropriate to transform the Bureau of Speakers into an Organ of the Community; and
- (b) encouraged the Bureau of Speakers to enhance the relationships between the Legislative Assembly and the National Assemblies/Parliaments as provided for under Article 65 of the Treaty.

6.0 CONSIDERATION OF ANY OTHER BUSINESS

7.1 Need for a Regional Strategy on the Management and Utilisation of Regional Oil and Gas Resources

The Summit observed the need for the Partner States to exploit and utilise the recently discovered oil and gas resources for the benefit of the people of East Africa. The Heads of State expressed the need to have sufficient trained capacity in the areas of negotiations: drilling and refining of oil and natural gas resources: transportation of products: and provision of reliable legal support. They further observed the need to study best practises from elsewhere in the world to enable the Partner States to substantially and productively manage the said resources.

The Summit directed—

- (a) the Secretary General to convene a Meeting of Ministers Responsible for Energy and Finance, the Attorneys General, Heads of Revenue Authorities and Chief Executive Officers of National Oil and Gas Companies to share experiences and agree on best practices; and
- (b) the Secretariat to work with Partner States and other relevant Partners in developing capacity at the national and Community levels in the management of hydrocarbons.
