**THE EAST AFRICAN COMMUNITY CUSTOMS
MANAGEMENT ACT 2004**

LEGAL NOTICE

IN EXERCISE of the powers conferred upon the Council of Ministers by Section 114 (3) of the East African Community Customs Management Act, 2004, the Council of Ministers has amended the Exemptions Regime under the Fifth Schedule to the Act as follows:

1. Amend Item 15 (a) of Fifth Schedule of EAC CMA 2004 PART B — GENERAL EXEMPTIONS to;
 - 1) insert the words “*and implements*” immediately after the word “inputs” and before the words “by persons engaged...”
 - 2) delete the words “*which the Commissioner is satisfied are for use in the horticulture, aquaculture, agriculture or floriculture sector*” and replace it with the words “*as recommended by the responsible Minister in a Partner State and subject to conditions and limitations as the Commissioner may impose*”
2. Amend Item 15 (b) of Fifth Schedule of EAC CMA 2004 PART B — GENERAL EXEMPTIONS to insert the words “*and fertilized eggs for incubation*” immediately after the word “stock” and before the words “by persons engaged...”
3. Amend Item 20 of Fifth Schedule of EAC CMA 2004 PART B — GENERAL EXEMPTIONS to insert;
 - 1) item “(i)” immediately before the words “*Goods for emergency relief purposes of such quantities and within...*”
 - 2) item “(ii)” immediately after the end of item (i) (e), be followed by the following words; “*Any supplies for diagnosis, prevention, treatment, and management of epidemics, pandemics and health hazards as recommended by the competent authority in the Ministry responsible for Health*”
4. Amend Item 26 of Fifth Schedule of EAC CMA 2004 PART B — GENERAL EXEMPTIONS by;
 - 1) deleting the words “*development and*” coming immediately after the words “equipment for” and before the word “generation”
 - 2) inserting the words “*Photovoltaic (PV) Modules, Direct Current Charge Controllers, Direct Current Inverters and Solar*” immediately after the word “Energy” and immediately before the words “Deep Cycle Battery which use and/or store solar power”.
